#### **DEFINITION**

The Dean of Students assists building administrators in the daily functions that are necessary to provide a safe and positive environment for students and staff.

#### **QUALIFICATIONS**

Preference given to candidates whose major is in a field related to children or who have previous full-time experience in a position working with children.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

(per Minnesota Department of Education guidance)

- Monitors student attendance, handles day-to-day discipline functions, refers students to behavioral intervention programs, directs student activities, and oversees extra-curricular events on a limited basis as assigned.
- Serves as a school representative at regional and state events, assists in local and state testing, assists administration and counseling staff with enrollment of new students. Liaison between district and law enforcement.
- Serves as an active member of assigned committees and participates in other district committees as appropriate.
- Contacts parents, arranges and attends conferences, coordinates with administration or counseling staff to assist in student development and needs.
- Works on school projects, initiatives and state reports, as appropriate, and assigned by principal.
- · Perform other duties as assigned.

#### Other Responsibilities:

- May be left in charge of the school in the absence of administrators as long as the duties and limitations cited here are honored.
  - Under no circumstances will the Dean of Students suspend/expel students or perform staff evaluations.
  - Oversight of Faculty and Staff will be limited to immediate needs and daily direction only, expressly following employee contracts.
  - No financial expenditures or authorization of purchases.
  - Contact Principal or Superintendent for activity, events or decisions that goes beyond those listed above.
  - During emergency situations follow protocol from crisis manual.

# Memorandum of Understanding between Willow River Education Association and Independent School District 577, Willow River

Whereas, Willow River Education Association is the exclusive representative for the teachers employed by Independent School District 577 (Willow River); and

Whereas, Willow River Education Association and the School District have negotiated a collective bargaining agreement ("Master Agreement") for the period of July 1, 2015, and June 30, 2017; and

It is hereby agreed that the Willow River Education Association and the School District that the School District will create a K-12 Dean of Students position, to be staffed by a Willow River Education Association member on special assignment. It is agreed upon that the member will receive additional compensation at a daily rate of \$16.76. If the position requires additional hours of service by the member outside the regular teacher work day; the Dean of Students shall be paid at their per diem hourly rate. This memorandum of understanding is for the remainder of the 2015-2016 school year, unless the School Districts terminates the position prior to the end of the year. If the Dean of Students position is terminated prior to the end of the year, the member shall remain employed at a 1.0 FTE in a position determined by the school district.
